| Incident | Action |

| Been in close contact with someone who | Inform your employer immediately. |
| has tested positive for COVID-19 | Your employer will explain what happens next in line with their incident reporting and self-isolation policy. |
| | Inform your training provider immediately. |
| | Your skills coach will explain arrangements for your next visit which will be delivered remotely. |
| | Arrange to have a test if you are showing any symptoms and inform your employer and training provider of the result. |
| Have tested positive for COVID-19 | Inform you employer immediately and follow government guidance on self-isolation. |
| | Your immediate family should follow government guidance and self-isolate for 14 days from when your symptoms started or 10 days from when their symptoms started. |
| | Your employer may contact NHS track and trace on your behalf, if not you should contact them and inform of your positive test result and be prepared to supply details of those you have recently been in close contact with. |
