Residential Apprenticeship Standard

As a Residential Childcare Worker you will make a positive difference in a young person's life. You will be responsible for planning daily routines, implementing activities and providing general care for the individuals within a residential setting. You will be expected to execute maturity, resilience and initiative to support the young people and build on their

development of life skills and education. By providing care, guidance and direction at the frontline of residential care, you will be instrumental in improving the health and well-being of those receiving care and support.

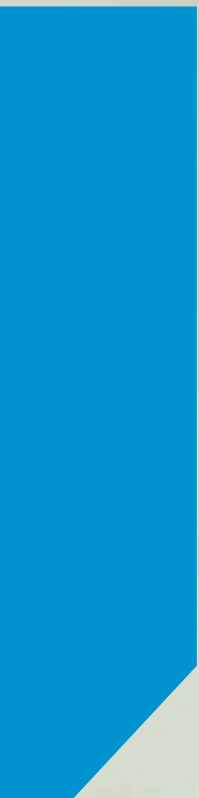
Entry Requirements

Apprentices must be at least 18 years of age. There are no other set entry requirements.

Functional Skills

Apprentices will achieve their level 2 functional skills in Maths, English, ICT, Employment Rights and Responsibilities, Personal Learning and Thinking Skills as part of this apprenticeship.





Main Qualification Structure

The apprentice must achieve a minimum of 61 credits, 53 of these will come from the mandatory units. There are 8 credits to be chosen from the optional units.

The qualification will be assessed using a range of methods. This could include direct observation in the workplace, a portfolio of evidence, written assignments or a task.
