- 3.1.6 To enhance the portfolio of qualifications on offer to our existing and new employer database
- 3.1.7 To support better geographical access for learners
- 3.1.8 To provide better access to training facilities
- 3.1.9 To offer an entry point for disadvantaged groups

4. Selection and Appointment of subcontractors

In selecting and appointing subcontractor/partner organizations GPSTL will only offer subcontract provision where the potential subcontractor meets the following criteria:

- 4.1 The potential subcontractor has been accepted on the Register of Apprenticeship Training Providers
- 4.2 The potential subcontractor meets our due diligence criteria
- 4.3 The potential subcontractor is a legal entity and is recorded as 'active' on Companies House
- 4.4 The potential subcontractor is registered on the UK Register of Leaning Providers (UKRLP)
- 4.5 The potential subcontractor holds a valid UK Provider Reference Number (UKPRN)
- 4.6 The provider has a minimum 'Good' Ofsted grading.

5. Reasons for not selecting and appointing subcontractors

- 5.1 The potential subcontractor has an average or below risk warning from the credit agency
- 5.2 The potential subcontract has passed a resolution to wind up or liquidate the company or administrators have been appointed
- 5.3 The potential subcontractor's/partner's statutory accounts are overdue
- 5.4 The potential subcontractor/partner does not meet our due diligence checks
- 5.5 The potential subcontractor/partner has an Ofsted or Care Quality Commission (CQC) rating of 'inadequate'
- 5.6 The potential subcontractor/partner has been issued with a high risk or significant high risk rating for Safeguarding by either Ofsted or the Care Quality Commission (CQC)
- 5.7 The potential subcontractor/partner has allegations of fraud
- 5.8 The potential subcontractor/partner has sanctions imposed by an awarding organisation
- 5.9 The potential subcontractor intends to second level subcontract

6. Decision and awarding subcontracting provision

- 6.1 The GPSTL Board of Governance will review and ratify the rationale and purpose of any potential subcontract procurement
- 6.2 The GPSTL Board of Governance will review and make the final decision on the appropriateness of potential subcontractor/s/partner/s following the completion of the due diligence process
- 6.3 We will not award a contract without ESFA written permission
- 6.4 Following issuance of contracts we will add the subcontract/partner details to the ESFA subcontractor declaration form

7. Policy dissemination

7.1 This policy will be disseminated to current subcontractors on initial engagement following successful due diligence and will also be available through the GPSTL website www.apprenticeships-gpstl.co.uk

All potential subcontractors will be made aware of the policy as part of the Due Diligence process.

8.1 This policy will be reviewed at least annually and in addition, in-year reviews will be undertaken as required to reflect any changes to the Education and Skills Funding Agency funding rules.
